PRODUCT DESCRIPTION

Rhizolizer[®] Prime Inoculant System for Soybeans is intended for nitrogen fixation and to improve crop nutrient availability and uptake.

DIRECTIONS

Shake all contents well prior to use. Use product within 24 hours of opening.

The application rate for the complete mixture is 0.775 fl. oz. per unit (140k) of soybean seed. Refer to product tech sheet for complete mixing directions and application information.

Tank Mix Restrictions: To maintain the inoculant's viability, Rhizolizer[®] Prime Inoculant System for Soybeans should be applied to the seed within 4 hours of being added to the mix tank. Only use non-chlorinated water.

ADVERSE CONDITIONS

When any of these conditions are present, Locus AG highly recommends at least a double (2x) application rate of the appropriate Locus AG soybean inoculant(s):

- Soil pH is less than 6.0 or more than 8.5
- Soil has not grown the specific legume for more than three (3) years
- Drought or flooding has occurred
- Topsoil exceeds 80°F
- Soil organic matter is below 1.5%
- Use of soil chemicals that are harmful to soil bacteria and inoculants
